Cancellation and Refund Policy: There are no refunds if you cancel later than one day before the commencement of class. If we are able to fill your spot prior to the first class, we will fully refund your registration fee. If you cancel anytime prior to the second class, you may request a credit of 50% of your registration fee be applied to a future class started within six month's time, but only if we can fill your spot with someone on the waiting list. There is no refund or credit after the second class.

RELEASE AND WAIVER OF CLAIMS

The undersigned, in consideration of the use of the facilities of Lucky Dog Sports Club, and whether participating as a spectator, a participant in dog training/competition activities, including but not limited to agility and obedience, or otherwise, covenants and agrees as follows:

General Release and Waiver. The undersigned hereby releases the owner of the property (SynerChi, Inc.), Planet Lucky Dog, Inc, dba Lucky Dog Sports Club, and the dog training activity sponsor(s), as well as the directors, officers, employees, instructors, contractors, agents and assigns of all of same (the "Released Parties"), from any and all liability for any losses, damages, costs or expenses of whatever kind or nature, including attorney's fees, which the undersigned has incurred or may hereafter incur resulting from any personal injury to the undersigned or his/her dog(s), as well as damage to any personal property of the undersigned, which liability is based upon or in any manner related to said facilities and the activities of the undersigned undertaken at same, which damages shall include, but not be limited to, loss of income, earnings, bodily injury, pain and suffering, emotional or mental distress and all medical expenses. In addition, the undersigned waives any claim which the undersigned now has or may hereafter have against the Released Parties based upon any claim of liability for personal injury or property damage suffered by the undersigned in connection with its use of said facilities and the activities of the undersigned thereon.

Assumption of Risk. The undersigned acknowledges and understands that the dog training activities undertaken involve potential risk of personal injury and injury to personal property, including dogs, which may result from the undersigned's participation in dog training activities. Such injuries may be caused by other participants, the undersigned, facility conditions including but not limited to, uneven or damaged terrain, the presence of moisture or mud, obstacles and obstructions upon or under the terrain and other natural or man-made conditions which may be hazardous to the undersigned or create hazards to the undersigned's activities. I understand that unleashing my dog and being physically present at Lucky Dog Sports Club involves risks of injury to me, any individual accompanying me, other people, my dog(s) and other dog(s), including but not limited to, risks resulting from aggressive dogs, unpredictable behavior, and lack of training. I further understand and assume that, despite the efforts of Lucky Dog Sports Club to ensure owners have complied, there is a risk that some dogs present in the dog park are not vaccinated for rabies as required by law, which could result in injury to a human or dog. Additional risks include, but are not limited to, dog fights, dog bites, escape over and under fences, mosquitoes, ticks and fleas. The undersigned further acknowledges that these dog training activities are potentially dangerous and assumes all risk of injury and/or damage, which may result from any reason whatsoever thereby.

I hereby agree to abide by the rules of Lucky Dog Sports Club, that no dog shall be physically or harshly verbally reprimanded while engaged in any activity sponsored by or affiliated with Lucky Dog Sports Club, or while on the premises of Lucky Dog Sports Club (with the exception of dogs committing acts of aggression towards people or other dogs). I further understand that any violation of this agreement could lead to the immediate termination of my involvement in the event or activity (including being asked to leave the premises) without refund of any monies paid for that event or activity. If, in the opinion of the instructor or Lucky Dog Sports Club, my dog is deemed to be a danger to other dogs or handlers I will be excused from further participation in class and/or events and no refund of fees are expected.

Binding Effect. The foregoing provisions shall be fully binding upon and shall be effective against the undersigned, its heirs, successors, legal representatives or assigns and shall apply to the actions of the undersigned personally, the undersigned's family, guests, employees or agents.
